R-II School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Eight Hundred Fifty Thousand Dollars (\$850,000) for the purpose of providing funds to replace the heating, ventilation, and air conditioning (HVAC) system; upgrade to campus to increase security; complete exterior/interior improvements; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.5786 per one hundred dollars of assessed valuation of real and personal property.

**PROPOSITION A**

Shall the City of Palmyra, Missouri, impose a sales tax of one-half of one percent ( 1/2 of 1%) for the purpose of funding capital improvements, including the operation and maintenance of capital improvements, within the City, which may include the retirement of debt under previously authorized bonded indebtedness? If approved, this capital improvement sales tax will replace the one-quarter of one percent (1/4 of 1%) capital improvement sales tax currently in place.

The approval of this proposition will authorize the imposition of a sales tax of one-half of one percent (1/2 of 1%), to be collected in addition to the other sales taxes provided for by law on all retail sales made in the City of Palmyra, Missouri that are subject to taxation under the provisions of Sections 144.010 to 144.525, inclusive, of the Revised Statutes of Missouri, as amended.
